New Delhi: The government is launching a multi-pronged offensive against the one lakh companies that have been deregistered, including action against those for violating taxation and money-laundering laws as well as choking their access to banking.

A day after Prime Minister

Narendra Modi's announcement that the ministry of corporate affairs (MCA) had struck off names of these companies, sources told TOI that all directors on the boards of these companies would be barred from similar positions on other corporate boards for five years, which is in line with the provisions

of the Companies Act. While the MCA has acted against them for not filing returns, it is now going to approach banks with the list of companies where action has been taken to ensure that they are unable to operate their bank accounts or access loans.

"In the past, we noticed that some of the deregistered companies continued to enjoy access to banking services due to lack of information flow. We want to prevent that, otherwise the whole purpose will be defeated," said a source, who did not wish to be identified.

Similarly, the ministry is writing to the Financial Intelligence Unit (FIU) to scan for any violation of provisions of the Prevention of Money Laundering Act.

Mumbai: Hotel Ambassador's Sky Chef, a well-known landmark located close to the international terminal of the Mumbai airport, has been served an eviction notice by the airport operator as it plans to use the land for operational purposes. The Mumbai unit of Sky Chef has been handling inflight dining contracts for a number of airlines since the eighties. 'On May 20, the 30-year old

Law dept says no to min's bid to save illegal SRA tenants

Mumbai: The state's law and judiciary department has strongly opposed housing minister Prakash Mehta's attempt to change the law to help regularise illegal occupants of SRA buildings.

Last year, Mehta had tried to stay the eviction of illegal residents in SRA buildings until the completion of a survey, by giving an assurance in the assembly. However, officials in both the law and judiciary and housing departments had opposed it, saying it would violate a court ruling.

In November, Mehta had suggested issuing an ordinance and amending the law to allow for regularization. "Given the large number of people affected, the government should issue an ordinance allowing for regularization after a penalty," he wrote to the housing department.



Long-distance trains to Guj hit due to heavy rain

Railways Gives **Breakfast To Those Stranded**

Mumbai: Scores of passengers were inconvenienced on Sunday as many longdistance trains towards Gujarat on Western Railway were delayed, regulated or diverted due to heavy rain in the Mehsana-Palanpur section since Saturday night.

Bandra Terminus and Dadar stations saw huge crowds as passengers waited for trains rescheduled on Sunday.

WR chief public relations officer Ravinder Bhakar said, "Fifteen trains were stopped and detained on the section as restoration work was in progress. The heavy rainfall resulted in soil cut and a major problem at four locations (level-crossings) en route. Staff sent for restoration work also faced difficulties due to continuous and heavy rainfall in

It had a cascading effect and trains leaving Mumbai on Sunday were delayed. Some trains from Ahmedabad to Ajmer and Abu Road were cancelled. "The incessant rain was a big challenge for our staff to carry out restoration work," said Bhakar. The affected sections were, however, cleared at the earliest and services resumed. "We delivered breakfast, water and other essential commodities to passengers of stranded trains, especially to passengers of 12915 Ashram Exp and 14707 Bikaner-Bandra (T) Ranakpur Exp," he said.

It is learnt that more than 1,000 food packets, 850 biscuit packets and 500 pouches of drinking water were supplied to the stranded passengers. The trains regulated and diverted were 12480 Bandra (T)-Jodhpur Exp (terminated at Mehsana); 14708 Bandra (T)-Bikaner Ranakpur Exp (regulated at Ahmedabad); 19707 Bandra (T)-Jaipur Aravali

Attempt to overreach court orders: Law dept

t is necessary to make a law so that no action is taken till the ordinance is issued. says a note written by Mehta to the housing department.

According to the existing rules, tenements allotted under the SRA scheme cannot be transferred for a period of 10 years. After that period, the permission of the SRA is needed before the transfer.

After Mehta's stand, the housing department proposed amending the Maharashtra Slum Areas (Improvement Clearance and Redevelopment) Act 1971. It proposed that the CEO of SRA be allowed to permit allottees to sell or lease their tenements before the 10-year period. It also proposed that this amendment be allowed with retro-

The state's law and judiciary department has given a strong rebuttal to the proposed amendment. "It also betrays an attempt to overreach judicial orders passed to achieve the object of the Slum Act," says a noting from principal secretary (law and judiciary) N L Jamadar on the proposal. TOI has a copy of the document.

Other law department officials also opposed the amendment. "The object of the Act is to make better provision for the improvement and clearance of slum areas and for their redevelopment. Therefore it may not be legally feasible to make such provisions as it may defeat the objects of the Act," says a note from the law and judiciary department.

The department also opposed allowing the amendment with retrospective effect. It pointed out that after HC orders in 2015, the state had been directed to initiate criminal proceedings against unauthorized occupants of SRA buildings.

Mehta was unavailable for comment. Currently, a cabinet sub-committee headed by him is examining the policy on the sale and purchase of SRA flats and unauthorized

Longer trips by autos, cabs could get cheaper

Panel May Hike Min Distance For Fares To 2Km

Mumbai: The governmentappointed Khatua committee will recommend new fares for autos and taxis this month.

The panel is considering increasing the minimum distance for fares to 2km, giving discounted fares for passengers travelling long distances or during peak hours (11am-4pm), and encouraging digital payments for commuters, sources said.

Transport department sources said the recommendations will ensure Kaali Peeli taxis and aggregator cabs like Ola, Uber have a "level-playing" field. An official said, "The panel will finalise minimum fares for all taxis/cabs and cap surge pricing in Mumbai. It will ensure drivers earn a decent income and end refusals for short trips. In some cities, the minimum fare is for 2km, which encourages drivers to accept short trips."

The sources said the department will consider discounted fares for long-distance routes. A telescopic fare

Panel to study impact of GST on industries

Mumbai: The state industries department will form a committee to study the impact of on industries in Maharashtra.

The current policy envisages encouraging industrialists to set up manufacturing plants in the state. "The policy is aimed at generating more revenue through various taxes. However, as far as GST is concerned, the tax slabs are the same across the country, which may not help a particular state to gain tax benefits from manufacturing," said an official from the department. "Thus, now its time to make changes in the policy. We need to give incentives to woo industries, like agroproducts, gems and jewellery or electronic items, that will manufacture and sell products within the state, instead of selling them in other part of the country, to generate revenue."

Industry minister Subhash Desaitold TOI that the committee will be headed by the department secretary. "During the VAT regime, we used to give incentives to industries in the form of refund; GST has changed the scenario. We have no clue about the impact. So, the department secretary will study GST and submit a report suggesting changes in the poli-

Sky Chef second hotel near airport to be issued eviction notice this year

fter the licence agreement between NIHPL and AAI expired, NIHPL no longer has a right over the airport premises, but they argued that the discussions between MIAL and NIHPL amounted to further extension of the licence period in the absence of a registered formal agreement," said the source, adding that upon preliminary hearing the court hasn't granted any relief to NIHPL. The matter is expected to come up on July 11.

The MIAL spokesperson refused to comment on the matter. Ambassador group requesting for a comment, but received no response.

Ambassador's Sky Chef launched its inflight catering business way back in 1942, but the Mumbai unit was set up only in the late eighties. Till then, inflight catering was handled from its hotel in South Mumbai. Around 1981, AAI had built a new terminal building in Sahar to exclusively cater to international flights as the one in Vile was saturated with growth in air traffic in the seventies. In 1987, AAI leased 15,000 sq m plot of land to ars, the strategically located new unit of Sky Chef (it's barely a km from the international terminal and about 3km from the domestic terminal) grew to handle catering contracts from a large number of domestic and international airlines. With a built-up area of 2,50,000 sqft, the unit produces over 30,000 inflight dining meals per day.

Sky Chef is now the second establishment located near the land-starved Mumbai airport to receive an eviction order from AAI. Early this year, the AAI served an eviction notice to Hotel Leela Venture, after the lease the 18,000 sq m land on which it stands expired. The government organisation alleged that the hotel had violated the terms of agreement as it had defaulted on payment of dues to AAI.

After prolonged litigations, AAI board decided to terminate the contract with Leela and notices were issued for payment of pending dues and handling over the possession of the property by October 31, 2016. After the deadline elapsed, AAI issued an eviction notice in February, which was contested by the hotel, which moved the court against AAI's eviction notice.

O-1 visas grew by 200% in 10 yrs

tatistics given by the US Department of Homeland Security (DHS) show that allotment of O-1 visas (O1-A and O1-B) has grown significantly over the years, from just 31,969 in 2006 to 93,086 a decade later. Awareness of this category is slowly building up in India and experts say their popularity will soon shoot up.

Such visas issued to Indians numbered 1,137 in 2015. A similar break-up for EB-1A is

not available. "For O-1A, it is important to demonstrate 'extraordinary ability', it is a high legal standard requiring evidence that the individual has risen to the top in his or her field. Awards (internationally recognized or lesser awards such as those on national level), publications, recognition in the media, patents, trademarks, academic contributions et all help substantiate it," explains David H Nachman, managing attorney, NPZ law group.

aharashtra has a strong presence in the Union cabinet, but there is only one secretary-rank officer in the central bureaucracy.

Sanjeevani Kutty, a 1983batch IAS officer, is one of the secretaries in the Union home ministry headed by Rajnath Singh. Maharashtra leaders--Nitin Gadkari, Suresh Prabhu, Anant Gite, Prakash Jawdekar, Piyush Goyal and Hansraj Ahir—hold key posts in Delhi.

Mehta and Aadhaar chief executive officer Ajay Bhushan Pandey were empanelled for appointment as secretary. A former chief secretary said that due to lack of state bureaucrats in Delhi, Maharashtra does not benefit in the decision-making

A Parsi Wedding

adabhai Naoroji, the grand old man of the country whose 100th death anniversary was commemorated the previous week, was also a professor of Gujarati at the University of London. On March 13, 1861, at the Liverpool Philomathic Society, the political and social leader presented a paper titled 'The Manners and Customs of The Parsees'. It gives a fascinating glimpse into Parsi life in Mumbai in the nineteenth century. Here, he describes a traditional Parsi wedding: "...the sister of the bride, under the pretext of washing the foot of the bridegroom with milk, steals away one of his shoes, and does not return it till a rupee is presented to her. The bride and the bridegroom are afterwards made to partake of a sweet dish, the bride giving a morsel to the bridegroom, and the bridegroom giving it to her, each instructed beforehand to eat only a little, or not at all... the couple, by turn, is made to find out a ring concealed in the morsel by the other. They are also made to gamble a little, and by these several tests the comparative merits of each are ascertained, I dare say, to the great satisfaction of all, especially of the ladies. The ceremony being over, the procession, with rows of lamps to light it, returns to the bridegroom's

house. The bride, however, does not accompany him then. Feasting follows... eight days after the day of the wedding another feast takes place. There are no tables and chairs. A long strip of cloth about 18 inches wide is spread upon the ground, and the guests take their places in a row on it. Each is then furnished with a piece of the plantain leaf, which he spreads before him; after each dish is served, a toast is raised from 'Glory of God' down to 'Happiness to the Couple'. As soon as one toast is drunk, a number of servants and friends of the host, with bottles in their hands, immediately apply themselves to replenish the emptied cups for the next toast...

Rain on a Train
